

The Mystery of Attraction

When the two disciples heard him say this, they followed Jesus. ³⁸Turning around, Jesus saw them following and asked, "What do you want?" They said, "Rabbi" (which means Teacher), "where are you staying?" ³⁹"Come," he replied, "and you will see." So they went and saw where he was staying, and spent that day with him. It was about the tenth hour. (John 1.37-39)

The Mystery of Courage

Jesus immediately said to them: "Take courage! It is I. Don't be afraid." ²⁸"Lord, if it's you," Peter replied, "tell me to come to you on the water." ²⁹"Come," he said. ³⁰Then Peter got down out of the boat, walked on the water and came toward Jesus. But when he saw the wind, he was afraid and, beginning to sink, cried out, "Lord, save me!" ³¹Immediately Jesus reached out his hand and caught him. "You of little faith," he said, "why did you doubt?" (Matthew 14.27-31)

ALL: Lord, give each of us in this parish the courage to step out in faith.

The Mystery of Compassion

So they went away by themselves in a boat to a solitary place. ³³But many who saw them leaving recognized them and ran on foot from all the towns and got there ahead of them. ³⁴When Jesus landed and saw a large crowd, he had compassion on them, because they were like sheep without a shepherd. So he began teaching them many things. (Mark 6.32-34)

ALL: Lord, teach us to reach out, with heartfelt compassion for the needs of one another.

The Mystery of Mission

After this the Lord appointed seventy-two others and sent them two by two ahead of him to every town and place where he was about to go. ²He told them, "The harvest is plentiful, but the workers are few. Ask the Lord of the harvest, therefore, to send out workers into his harvest field. (Luke 10.1-2)

ALL: Lord, send us forth and give success to the work of our hands.

Annual Congregational Meeting Monday March 1st, 2004

The AGM of All Saints Parish Congregation was well attended this year with a hot roast beef dinner served to the approximately ninety people who attended. The meeting got underway at 6:30 with Calvin Taylor chairing the meeting. He thanked all those in attendance for showing their support by being there. He referenced the need for volunteers within the parish and advised that more people were needed to fill positions which would be advertised throughout the evening.

After grace the meal was served, followed by a Thanksgiving Liturgy which was delivered by Canon Thomas, as well as a gospel reading read by Isaac Petten.

The first order of business was the approval of the minutes of the last AGM, motioned by Al Decker and seconded by Shirley Batten.

Following this, Barry Tilley presented the financial statement for the parish, noting that the parish must work towards reversing some negative financial trends which have been set during the past year, including reduced offerings which has resulted in running a deficit for the year amounting to approximately \$3,500.00. The report was accepted after motion was put forth by Barry and seconded by Eric Taylor.

Barry Tilley then presented the budget for the 2004 fiscal year. The total budget was set at \$308,800. This includes a 2% increase in wages for non-clergy staff. Barry noted that several changes have been made to this year's budget, including projected income from the ACW to be increased to \$5,000. As well, the Parish will continue to support PWRDF, Queen's College and the Canadian Bible Society by forwarding monies received for these groups, but will not set an actual budget amount as was done previously. It was noted that any budget surplus will be directed to these groups to bring donations up to year 2003 commitments. Some disappointment was expressed that budget commitment was not made for PWRDF, Queen's College and the Bible Society as previously done. The absence of a food bank contribution was also noted and some disappointment was shown regarding this. In response, Barry Tilley and Kevin Pittman referred to the Parish's weak financial position and therefore, its inability to continue to maintain some commitments made in previous years. During discussion, it was stated that we need to challenge ourselves to be more generous with our givings to God. Motion to accept the 2004 budget as tabled was made by Kevin Pittman, seconded by Ken Scott, and carried.

Calvin thanked Barry for his dedication and free time which he continues to give to All Saints in looking after the finances.

Parish reports were then presented for acceptance beginning with the Rector's Report. Highlights included:

- •staffing changes, notably, Madonna Lawrence's retirement in May followed by the hiring of Kim Oake as parish secretary.
- •new programs/organizations which were started throughout the year including Men's Fellowship, Drama Troupe, Mom's & Tot's, monthly Folk Eucharists in the parish hall just to name a few.
- •upgrading expenditures made, including a new copier for the office, windows for the south side of the church, choir gowns and copies of Common Praise for the choir.
- •the large number of funerals, weddings, baptisms and confirmations at All Saints.

Canon Thomas also referenced his intention to resign as Rector of All Saints on August 31st, 2004. He formally thanked all those who have assisted him in all aspects of parish life and work during his time here. Canon Thomas then moved that his report be accepted. This was seconded by Ros Butler and carried.

Following the Rector's Report, Reverend Burrows also spoke to his report which was contained within the complete package. Reverend Burrows stressed his delight with seeing the amount of youth involvement within this parish continuing to grow. He also referenced the work of those who have committed to the All Saints Drama Troupe and commended their efforts. Regarding Stewardship, he stressed the need to make All Saints a climate which people will want to be part of and to share resources with. Reverend David motioned to accept this report, which was seconded by George Petten, and carried.

Other parish organizations forwarded annual reports which are contained within this document. They include the following:

ACW Report.....including all associated reports and financial statement.....Motion to accept made by Minnie Gullage and seconded by Barb Tilley. Carried. Dot Reid spoke to this report by stressing that there is need for greater involvement in ACW activities from ALL women of the parish, from all ages!

Foxtrap CLB Company 4435....motion to accept this report was made by Greg Taylor and seconded by Rev. David Burrows. Carried.

Cemetery Report....Motion to accept the report as contained within was made by Eric Taylor and seconded by Les Haines. Carried

All Saints Parish Salmonier Correctional Institute Report....Clarissa Hiscock motioned to accept this report, seconded by Amanda Cable. Carried.

CBS/Paradise food Bank Report....Heber Best made motion to accept this report. This was seconded by Len Pecore and carried by all.

Canadian Bible Society Annual Report....Motion to accept this report was made by Shirley Parsons and seconded by Len Pecore. Carried.

Catering Committee 2003 Report....Motion to accept the report was made by Eric Taylor and seconded by Dot Davis. Carried.

Elections for Vestry members followed the acceptance of reports. The voting results were as follows: Debbie Rideout, Rod Batten and Sam Butler were elected to serve a **three year term**.

Greg Taylor and Paulette Warford were elected to serve a two year term.

Herb Butler was elected by acclamation to serve as People's Warden for a three year term. Herb's name was brought forth by the Vestry Nominating Committee.

Barb Tilley was selected as the ACW representative to sit on Vestry. She was nominated by Vera Baird and this was seconded by Minnie Gullage.

Two new members were appointed to serve on the Program Committee to replace those stepping down. Nancy Anne Batten and Ruth Pittman were both nominated and accepted. No other names were brought forth.

After the formal business for this event concluded, Chairman Calvin Taylor challenged the congregation to address the responsibility relating to parish concerns such as the physical state of the church property. He suggested that we may have to consider major repairs, renovations or reconstruction in the not too distant future. He alluded to the major commitment which will be required by all who are members of All Saints to resolve the many issues which face this congregation. He then offered thanks to everybody who attended this meeting and helped in any way.

Canon Derek concluded the meeting with prayer at 9:35 p.m. and Saints Alive closed out the evening with song.

ACW ANNUAL REPORT

Rev. Barter, Madam President and Ladies of ACW. I am pleased to submit this report of our activities of ACW for the past year. All our meetings were well attended and they all began with devotions and short mediations on bible readings for the theme chosen. This past year we hosted two parties for our Seniors, one for Epiphany and one in June. Every Tuesday some of our ladies visited the nursing homes in C.B.S. for singing and prayers, and cards are being sent out to the sick, shut-ins and the bereaved. On Shrove Tuesday we did the pancake supper with proceeds going to the ministry to the deaf. We prepared & served the Sedar Meal again this year and also did a project for PWRDF during Lent. In the spring we held a flea market, bake sale and rented tables, we also sold soup & sandwiches. In November we had another sale with the same events. We prepared and served the Thanksgiving Jiggs Dinner and helped with the Fall Fair activities. In October we had our Halloween Rock-a-thon serving ham and beans this year. This went very well and grows every year. We had spring and fall deanery fellowships. One was held at St. Michaels and one at St. John the Evangelist, Topsail. Two times this year we had fellowship time with a friend we invited to a game of cards. Our ladies were pleased to help make palm crosses for Palm Sunday and to serve with the Altar Guild. This year we donated a quilt for the breast cancer research, this would be on display and then auctioned off by the Cancer Society. Some of our ladies are on the bereavement committee, and we serve lunches after fellowship services whenever asked to do so. We attended and took part in the World Day of prayer and some of our ladies are still helping with St. Luke's Homes, serving tea on our scheduled times and helping with afternoon teas. Our family life department has been busy sending out birthday cards to the children and making booties and crosses for the babies baptized. Our youth department held the Christmas Eve party for Jesus' Birthday and on Good Friday held a children's service. We have kept in touch with the youth during the year and helped whenever asked to do so. The Vacation Bible School went well and some of our ladies prepared and served lunches each day.

We have had our fun times during this year. We enjoyed Fellowship evening with the Salvation Army Home League, Long Pond, our Annual Valentines party, bowling every Wednesday, the organized Hall Walk twice a week and our Christmas party held at our hall with Topsail ACW joining us. We had three outings this summer when our ACW was closed. Some of us attended the Government House Garden Party and later toured Government House. We have had craft nights and we have had guest speakers. Our craft group meets every Monday and this time is very much enjoyed. Two of our ladies attended the Annual Meeting of the ACW Eastern Diocese at Lavrock in September.

In July we said farewell to Canon Thomas and Nellie and we have enjoyed having them and we wish them well in the years to come. Then in September we welcomed Rev. Byron, his wife Rose and son Matthew. We look forward to working and sharing ministries with them.

We have had a busy and rewarding year in ACW. Thank you to all who give so much of their time for the Lord's work here at home and away. May God bless you all.

PRISON MINISTRY

The Prison Ministry Team continued to minister at the Salmonier Correctional Institute until it closed in June.

During the year, January 1, 2004 to June 9, 2004, Prayer and Praise services were held every second Wednesday and Eucharist on the first Sunday of each month. All services were held at 7:30 pm. The ministry began July 11, 1995 and ended on June 9, 2004 with a total of 333 services.

Two members were invited to help plan and participate in the Ecumenical Service of Thanksgiving held on June 14, 2004 at the Salmonier Correctional Institutional Chapel.

A service to bring closure to the ministry at All Saints was held on June 13, Fellowship Night. The Prison Ministry Team conducted the service. Modeled on the Prayer and Praise services held at SCI. Each member witnessed as to what that ministry meant to him/her.

A letter of appreciation fro the All Saints Ministry at SCI was received from the Institutional Services Branch of the Department of Justice.

"Do not worry about how you are to speak or what you are to say; for what you are to say will be given to you at that time; for it is not you who speak, but the Spirit of your Father speaking through you."

Matthew 10:19-20

Two members of the team, David and Jocelyn Fagan, continue their ministry at Her Majesty's Penitentiary participating in the one-on-one ministry one night a week and in the Sunday morning services. Please support them with your prayers.

The team continue to participate in Prison Ministry. It is true that "When one door closes, another opens." In November the Parish was requested to participate in the Angel Tree Ministry. "Angel Tree is a program of Prison Fellowship Canada that provides Christmas gifts to prisoners' children who might otherwise be overlooked during the Christmas season. Angel Tree provides a crucial link between children and their imprisoned parent. Incarcerated parents who have neither the money nor the mobility to provide Christmas presents often feel hopelessly frustrated when they think of their children during this time. By providing gifts in the name of the imprisoned parent, volunteers enable prisoners to know that their children are being provided for and the children know that their parents have not forgotten them."

We were privileged to respond to two requests. We have agreed to be involved in this program.

PROGRAM COMMITTEE

The Parish Program Committee consists of 14 elected members and clergy. The commitment and aim of this Committee is to promote awareness and learning in our Parish. The Committee is divided into 3 sub-committees: Worship, Outreach and Parish Life, each with its specific ministry and responsibilities. There are many avenues used to promote learning and awareness.

The area of **Worship** deals with the needs of groups to help in our worship such as Sidespersons, Servers, Readers, Liturgical Planners, Greeters, Eucharistic Assistants, Choir and Worship Bands. Ongoing training and fellowship are available to these people.

The Outreach part of our program are normally ministries that are for others beyond our Parish, for example, Primates World Relief and Development, Food Bank, Meals on Wheels, the Christmas Shoe Boxes and Visitation to homes. Information leaflets, posters and education are part of the ongoing awareness of the needs of our neighbours in our communities and around the world.

The area of **Parish Life** deals with communication, education and fellowship in our Parish. The ministries used for education include Sunday School, Life in the Eucharist, Confirmation, Bible Study, Youth programs and CLB. There are many avenues for spiritual development that include Stewardship, Prayer Chain, Cell groups and Cursillo. The Funeral Reception ministry in our Parish has been very well received and is a wonderful blessing to many people during a very difficult time in their lives.

The Program Committee meet approximately 6 times a year and we constantly seek to improve areas of Parish Life that will enhance our ministries.

CLB FOXTRAP COMPANY #4435

It gives me great pleasure to present to you the 2004 annual report of the Foxtrap CLB. The company opened in September with approximately sixty young people. The younger sections seem to be the most dominant sections in the company. This indicates that the CLB is a positive influence in the lives of our young people.

Our company has had another busy year. Throughout the year we have taken part in many activities both on the company level and the Battalion level. This year activities included outings, sleepovers, Christmas parties and company fundraisers. We would like to take this opportunity to thank all of those who helped in our fundraising efforts. On the Battalion level we participated in sporting tournaments, Challenge Camp (senior section), and the annual camp at Mint Brook (JTC's and seniors). We also attended all of the Battalion parades including the anniversary parade, the winter parade, and the spring parade.

The LTC section (aged 5-6) is just as busy as the rest of the Company! September 2004 marked the 50th anniversary of the LTC's in the CLB in Newfoundland and Labrador. Our LTC's participated in many of the celebration activities associated with this. They also attended a fun day at the Armory. The CLB is a competitive program designed to teach young people discipline and to make them good Christian children of the Church. I would like to thank the staff and volunteers for their support and their loyalty to the company. To the youth of the CLB: Let's keep the flag flying and be proud of what we do.
