January flew by, then February saw us with our T&E Exams and our weekend outings at the Old Comrades Lodge #2 Wilderness Site for each of the YTC, JTC and Senior Sections. These weekends are usually very well enjoyed by all involved, however this year we were hampered by weather one weekend and issues with the generator at the cabin during the other two. March saw our LTC Section have a sleepover at the Parish Hall, and many members of each section enjoy the Battalion Fun Day at the Max Center in St. John's. March also saw our annual "Newfie Kitchen Party" dance/fundraiser, which was once again sold out and a huge success. Most of our members participated in the Battalion Travel Sweepstakes ticket sale again this year as well.

April was yet another busy month. Our Seniors enjoyed a day of rock climbing, the LTC's went back to Sobeys, this time to decorate Easter cakes, and both our LTC and YTC sections had an Easter egg hunt. We also had a Recycling/Beer Bottle drive in April, which was yet another success. Our Seniors finished off the month with a day of paintball. May saw a busy year of regular parades, Church parades, staff meetings and a variety of fun activities conclude with our Annual Banquet and Inspection. The year 2014 was a very busy and productive year for the Ways and Means Committee. Countless hours for the committee went into planning and organizing the yearly events. An amount of approximately \$841.00 was collected from these events. We ended 2014 by holding a New Year's Eve Dance, bar service was provided, a live band was in attendance, munchies for the tables, party favours and lots of finger foods were available throughout the night. attendance was low but the people who did attend really enjoyed the night, this event minus expenses, we collected \$522.00.

Members of the Committee are very dedicated to planning, organizing and spending countless hours to make each event a success, fun and fellowship has certainly been developed over the years. Thank you to all who supported us in 2014. Total amount submitted to the parish minus expenses on behalf of the Ways and Means Committee was approximately \$21,000.00.

On a go forward basis for 2015, our scheduled events are: Open Mic, Skit Night, Spirit of the Sea Festival, Monthly Luncheon and Card Game and New Year's Eve Dance.

In 2014 the CBS/Paradise Food Bank was very busy serving many of the less fortunate in the community.

The Food Bank is supported by 14r local churches, two town councils, businesses, service clubs, youth organizations, schools and individuals.

Fay Dawe is the only paid employee and she operates the Food
Bank in a very efficient and caring way. The board members do their part when needed. There also some volunteers who help on a regular basis.

Every Sunday many of our parishioners donate food or monetary donations. The food is delivered weekly to stock the shelves and the monetary donations used to purchase items as needed. This year I delivered approximately 20 grocery carts of food and \$4121.05 was the yearly donation.

In 2014 the Food Bank prepared 1324 hampers. This number of hampers helped 1692 adults and 788 children. Also, this year we had 97 new clients.

Also we supply lunches for children in schools when requested.

Thanksgiving and Christmas are the busiest times of the year. People support the Food Bank very generously with food and donations.

Our Christmas Hamper Appeal was very successful this year with \$2730.00 received. Our parish is responsible for 40 hampers. However, this year instead of hampers, we gave out gift cards, plus a turkey (\$50 single family, \$75 medium, \$100 large). A total of 240 families were served.

This being our first year, I can report that it went very smoothly and it was received really well by the clients.

This Christmas was a very good year with lots of groceries and monetary donations. Also all the turkeys were supplied by Community Food Sharing, the CBS Town Council, Businesses and personal donations.

I would like to thank the parish for letting us use the Parish Hall for our monthly meetings. Thank you to Rev. Sam for helping us during the Christmas Hamper delivery. Also, it was a pleasure to have this year's confirmation class and their leaders at the Food Bank, where they could learn the operation first hand. They also donated food plus \$581.71.

In closing I would like to thank the parishioners of All Saints who donate on a regular basis and to encourage more parishioners to help the Food Bank in their endeavors.

So please continue to keep our grocery cart full or make a monetary donation and make it a Sunday ritual. God Bless.

All Saints Anglican Parish <u>Annual General Meeting</u>

2014 produced another busy year for the Cemetery Committee, our Caretaker, Kevin Hunt, and his student assistant Thomas Fagan.

All individuals involved with the Committee and employed to work in our Cemetery sites did so with great pride wanting to present and provide the cleanest and most beautiful environment to those who visit and those who have to avail of our services. Unfortunately, our sites continue to grow and therefore the amount of work continues to grow as well.

This past year we were able to avail of some funding under the Level I, II, III Student Summer Employment Program but the value of the Grant and the amount of time provided with it were less than required, or we would have liked to have benefitted from. As the cost of materials and supplies increase and we foresee the requirement for an assistant to our Caretaker when the work season begins in May, prior to the availability of Student Grants, we began to prepare ourselves for the future in order to provide the same high level of service and Perpetual Care that is expected, and so many have very positively commented on throughout this past year and prior about our Cemetery sites. The only way to prepare for these increased costs and requirements was to enact a Plot Fee increase which took place in June 2014 as approved by Vestry. This was the first Plot Fee increase that had been put into effect since 2008. In October 2014, to utilize the land use and extend the life of the Dunn's Hill Cemetery a Cremation Plot area was established. The use of these Plots will extend the capability of that site for many, many more years.

This past May we called on volunteers in our Congregation to come out one evening to the Dunn's Hill Cemetery to assist with cleaning of the Cemetery and removing garbage that had accumulated over the winter. There was a great turn out for the evening and it was a great eye-opener to those present as to the types of debris that litter such a place of sanctity. It was also seen how disrespectful members of our community are to such an area with the illegal dumping of garbage.

We continue to ask the visitors to our Cemeteries to be mindful of the materials that they leave when visiting a gravesite. The placement of wire flowers, glass vases and ornaments continues to create work and safety hazards to our workers and those visiting the Cemetery when they have not been removed in a timely manner. October as always was designated as clean up month and produced quite a number of articles having to be removed from gravesites in preparation for the winter so hazards and debris would not be created over the winter months and have to be dealt with in such a high volume at the start of the 2015 Caretaker season.

Our Committee is active throughout the year always rising to the need when there is a requirement for assisting Kevin with any job that might be required, whether mowing grass, raking, or taking numerous evenings and correcting the placement of headstones after settling has occurred.

We would like to take this opportunity to thank Kevin Hunt for his continued good work as our Caretaker. This was also our second year having Thomas Fagan assist Kevin for several weeks during the summer and we appreciate the hard working assistance that he had provided to Kevin. Thanks as well to the Committee volunteers, and those who had volunteered in any capacity throughout this past year. Please know that your assistance and time continues to be greatly appreciated.



2014 was another great year for All Saints Parish...


- 2014 was a unique year in that we operated utilizing a variety of part-time and temporary Clergy personnel, all of whom contributed to maintaining a very busy ministry program

Overall Consolidated Picture


Revenue and Expenses 2012 vs 2013 vs 2014


- * Revenues were slightly down (2.9%) from last year
- Expenses are down significantly (38.8%) due to closedown of our Restoration Project, and reduced clergy costs









Cemetery Fund

- ✓ We still need your support in this area for another couple of years


